पूर्व डीजीपी सैनी की गिरफ्तारी पर रोक

जनसत्ता ब्यूरो नई दिल्ली, 15 सितंबर।

उच्चतम न्यायालय ने पंजाब के पूर्व पुलिस महानिदेशक सुमेध सिंह सैनी को 1991 में एक जूनियर इंजीनियर बलवंत सिंह मुलतानी की हत्या के मामले में मंगलवार को गिरफ्तारी से अंतरिम संरक्षण प्रदान कर दिया।

न्यायमृर्ति अशोक भूषण, न्यायमृर्ति आर सुभाष रेड्डी और न्यायमृर्ति एमआर शाह के पीठ ने सैनी की अपील पर पंजाब सरकार से जवाब मांगा है। सैनी ने इस मामले में उन्हें अग्रिम जमानत देने से इनकार करने के पंजाब व हरियाणा उच्च न्यायालय के आदेश को चुनौती दी है। वीडियो कॉन्फ्रेंस के जरिए इस मामले की सुनवाई के दौरान पीँठ ने पंजाब सरकार की ओर से पेश वरिष्ठ अधिवक्ता सिद्धार्थ लुथरा से जानना चाहा कि 29 साल पराने मामले में सैनी को गिरफ्तार करने की जल्दी क्या है। लथरा ने जवाब दिया कि 'जेड' श्रेणी की सुरक्षा प्राप्त पूर्व पुलिस महानिदेशक फरार हैं। पीठ ने इस मामले को चार सप्ताह बाद सुनवाई के लिए सचीबद्ध करते हुए कहा कि सैनी को अगले आदेश तक गिरफ्तार नहीं किया जाएगा और वह जांच में सहयोग करेंगे।
